Please clarify whether the valves and actuators provided by Contracting authority will be painted as per your requirements and repainting will not be necessary;	Please see item 7.1.3. of Technical specification - Painting materials shall be provided by the Contractor. The following items shall be painted; valves, hydro-pneumatic actuators, welds and welded pipe spoons. Paint - White RAL 9017; Grey RAL 7040. (Tehniskais uzdevums 7.1.3 punkts. Krāsošanas materiāli.
